- b. Need for training programs, i.e. administration, leadership, and economics.

c. Suggestion: Western University could design programming for community needs, via microcredentials or diploma offering in Indigenous Band Administration for example.

- e. "Schulich is not where it could be, slightly behind", functioning in a colonial institution

 - iii. Create space of safety and belonging

- h. Partnerships: beyond transactional
- i. Ongoing monitoring, making space for public and transparency
- j. Enact Mini-Goals for each year-possible collaboration with EDID office and Schulich
